



Open Internet Explorer type https://ftp.ipsfiserv.com in address bar, click enter. This takes you the Fiserv Movelt site. Enter, SCO2client for the username, and Ip\$co0328 (that is a capital i) for the



When download is complete (*if using Google Chrome, Mozilla FireFox or Microsoft Edge for scanning, see below before beginning the scanner installation), sign out and close window. Make sure the usb cord is unplugged from the back of the scanner before starting install. Always install scanner driver before Ranger Remote.



Select desktop, save



/ SupportUsers/SCO2client/RangerDriversAndSoftware/DigitalCheck CX30/ corner. Foote, Ra Click show in folder

If you are downloading in Chrome, it will look like this, and you will click the arrow in the bottom left

Right click ranger folder for CX30, click run as administrator

Box will open, click on "Install" (install may take a few minutes), tiff window will open, click on "allow blocked content", close window. Box will open prompting a restart, click on yes. **Note, if using a different browser other than Internet Explorer, see Ranger Remote install instructions below before doing restart.



You will need their IT

If they do not have admin rights, you will see this box. tech to procede.


After the restart, log back in to Windows (computer), plug scanner back in. ***Make sure Ranger Remote server has started.

To check if scanner is communicating with the new software, go to Start, Silverbullet, Ranger/RangerFlex



You should see "silverbullet" splash on the screen and the scanner should turn on, click file and exit.


Delete SCO icon from desktop, right click, delete Open Business Online Banking check compatibility view and trusted sites before they log in. This does not need to be done if they are not using Internet Explorer.




Go to Tools->Compatibility View Settings

secureinternetbanking.com and *.fiservsco.com should be in compatibility view

When checking trusted sites, make sure the box "Delete browsing history on exit" in unchecked, this is



Go to Tools->Internet Options->Security Tab->Trusted Sites->Sites






The bank site, secureinternetbanking.com and *.fiservsco.com should be in trusted sites.

*If client is using Google Chrome, Mozilla FireFox, or Microsoft Edge follow instructions below after downloading scanner driver.

Go back to RangerDriversAndSoftware folder.



Note, you will need to install the scanner driver before finishing the install for Ranger Remote.

**When scanner installation is complete, click No, OK, Complete and follow instructions below.




Right click Ranger Remote icon on desktop

You will be prompted to do a restart when installation is complete, do restart now.

***You will need to make sure the Ranger Remote server has started.

An Icon will appear in the bottom right taskbar.



Right click the icon, if you do not see **Stop Server** select **Start Server**.
